#### *One-Day Class Assists Potential Applicants For Technical Assistance*

RALEIGH – The North Carolina Energy Office has added third set of sessions to the series of one-day classes to help potential applications for Federal Recovery Act funds under the Energy Efficiency and Conservation Block Grant program. Governmental entities are free to select any other firm not on the list, however they will be responsible for any expense associated with their selection.

Government entities must submit a strategic energy plan with their RFP response to be considered for an award. Attached is the application that must be completed to access the technical assistance.
